<b>AGE LIMITS</b>	Senior gymnasts: born in 2001 or before. Junior gymnasts: born in 2002, 2003 or 2004. Only Gymnasts with the correct age and having a valid FIG license until the end of the event may participate.

<b>JUDGES AND JURIES</b>	<b>All judges must hold a current valid FIG brevet at the time of the event.</b>	
<b>ENTRY FEES</b>	<b>50 EUR</b> per each individual gymnast <b>100 EUR</b> per group  The Entry fee for the competition must be paid in cash after arrival.	
<b>ACCREDITATION</b>	Accreditation of all delegations will take place upon arrival.  Heads of delegation or coach have to check the names of their own delegation members, hotel reservation; they also have to effect all necessary payments.  Heads of delegation have to bring to accreditation office: <ul style="list-style-type: none"> <li>▪ passports of all members of the delegation</li> <li>▪ FIG licenses for each gymnast</li> <li>▪ Medical insurance for each delegation member</li> <li>▪ a CD with the national anthem and the national flag</li> <li>▪ 2 copies of CDs with music for the programs (each gymnast)</li> </ul> In order to speed accreditation procedures, please send to the LOC a photo of each member of the delegation (in electronic format) together with the nominative registration. <b>Note:</b> Photos taken upon arrival shall be charged to the National Federations at a cost of <b>10 EUR each</b> .  Accreditation card is personal for each of the delegation members. Accreditation card wearing is required at all times of the event.

<b>MEDICAL SERVICES</b>	The Organizing Committee will provide a first medical aid service.
<b>VISA</b>	<p>Please verify immediately with your travel agent or the Ukrainian Embassy or Consulate in your country if a visa is required for your travel to Ukraine.</p> <p>The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made to the LOC before <b>February 16, 2017</b>.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: <b>10 EUR per person/day</b>.</p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federations must pay for the International travel costs of their delegation members.</p> <p>The Travel Schedule Form must be returned to the LOC by February 16, 2017.</p>
