Should flights have to be cancelled due to the above, the risk is at the charge of the participating member Federations (NF).</li> <li>The participating member Federations (NF) may cancel its participation in a specific category without any penalty or payment for fees, accommodation and meals already booked, in case of less than 4 participating countries in that category after the definitive deadlines.</li> </ul>
